_____Application: One (1) complete copy of this Application.

_____Property Interest/Consent of Owner: A copy of the deed, lease, sales agreement or other contract proving interest in property with the filing of this Application. If the applicant is other than the owner of the subject property, then signed consent of the property owner must accompany this application.

_____Drawings of Proposed Sign: One (1) set of scaled drawings of the proposed sign, indicating all dimensions, equipment/material descriptions, the specific lettering, symbols and graphics to be located on the sign face, and any other information requested by the Code Enforcement Officer. If the proposed sign is to be attached to a building, then the Applicant shall include a scaled drawing of the location of the sign on the subject building, including all dimensions.

_____Location Map: One (1) copy of a scaled site plan showing the location of the sign on the subject property, all buildings and structures on the subject property, and the distance of the sign from all property lines, buildings and structures.

Engineer's Design: Where necessary to properly consider the application, applicant to provide an engineer's design of the proposed sign.

_____Application Fee: Full payment of the application fee and any deposit required by the Township
